The Bids must be accompanied by copy of valid contract Registration Certificate, VAT clearance, Pan Card. Labour License.
4. The Sale of the Bid document will start on 12/12/2011 during office hours and will be closed on 22/12/2011 at **3.00PM** in the office of the undersigned. The bid documents will be available in the office as mentioned in column No.8 on payment of cost (non refundable) mentioned in column No 7 in shape of Cash.
5. Sealed tender in complete shape will be received on working days from 12/12/2011 to 22/12/2011 Up to 5.00 PM. in the office of the undersigned. Sealed tender will also be received by **Speed post/ Regd. Post** within the stipulated date and time i.e. Up to 22/12/2011 (**5.00 PM.**). Tender received by post after **5.00 PM on 22/12/2011** will not be considered. The Department will not be held responsible for any postal delay or loss or damage of the tender during transit.
6. The authority will not be responsible if any portion of the document is not included or modified other than the approved one, as available in the Office of the Chief District Medical Officer, Balasore.
7. The Engineering Contractor applied for exemption of EMD has to produce the original contractor license at the time of opening of tender for making necessary entry of exemption of CM. Non production of original license at the time of opening of tender will be treated as disqualified.
8. The Bids will be opened at 11.30 A.M on 23/12/2011 in the office of the undersigned in presence of the bidders or their authorized agents. If the office happens to be closed on the date of sale, receipt and opening of bids, the bids will be sold, received and opened on the next working day at the same time and venue.
