1. Paper quality: 60GSM good quality cream wove with Demi ¼ size sample should be submitted along with the quotation paper
2. Quality of printing: Letter size as per sample (which can be collected from DPO, SSA, and Balasore).
3. Place, date and time of receiving the quotation: District Project Office, SSA, Balasore, Public High School Campus, Balasore on or before dt. ~~16.8.10~~ by 2.00PM. **ONLY THROUGH SPEED/REGD. POST.**
4. Opening of quotation: Office of the DPC SSA, Balasore on dt. ~~16.8.10~~ at 3.00 pm in presence of the bidder or their authorized representative and the tender committee.
5. Processing charge: Rs.500/- (Rupees five hundred) only (non refundable) should be submitted in shape of DD in favour of DPC, SSA, Balasore.
